



## DHONI STELLA – MALDIVES PRIVATE CHARTER

RATES AND CONDITIONS FROM: **JANUARY 2021 TO APRIL 2022**

**CHARTER RATES INCLUDE:** Meals, water/soft drinks, airport pick up/drop off, crew (1 captain, 1 cook, 1 steward, 1 divemaster); fuel (up to 3 hrs average per day of navigation – US\$ 100 for additional hour); motorized tender/dinghy, and WIFI Internet.

**CHARTER RATES DO NOT INCLUDE:** Service Charge\* (10%), VAT (12%), Green Tax (US\$ 6 per person per day), alcoholic drinks, scuba diving, and yacht delivery or re-delivery other than to Male airport.

**FESTIVE SUPPLEMENT:** US\$ 250 per night (between 24-Dec and 6-Jan included).

**Notes:** Passengers cruising between 27<sup>th</sup> December and 4<sup>th</sup> January (inclusive) must book a minimum of 7 nights. Eventual supplements could be charged in case of increase of fuel rate or modification of the current local taxes.

**SPECIAL OFFER: 10% OFF ON CHARTERS WITH 2 PASSENGERS**

This offer is applicable if only two passengers are on board.

**SPECIAL OFFER: Free Nights between 1-Jan-21 to 30-Apr-21**

**Payment and cancellation terms:** 30% is due at the reservation; balance is due 60 days before the charter starts. Cancellation fee: 30% if booking is cancelled 90 to 60 days before arrival date; 100% for cancellation at later date. **Special terms are applied during COVID-19 pandemic.**

**Cabins occupancy:** Stella 1 counts 2 cabins for 4 passengers: one with king size bed and one with twin beds. Stella 2 counts 2 cabins for 6 passengers: each with 1 double bed and 1 single bed.

**Check in and check out:** When possible, time will be arranged as per passengers' request.

(\*) The Sixth Amendment of the Employment Act made service charge a mandatory levy in the Maldives tourism sector from 1<sup>st</sup> January 2021 onwards.
